

**CRPF SHAHEED FUND CWA**  
**CRPF FAMILY WELFARE ASSOCIATION**

CRPF Wives Welfare Association (CWA) with motto 'Sarthak Sahyog Sarvada' is a registered NGO committed to look after the families of martyrs and Central Reserve Police Force personnel who are away from home while serving the Nation in different distant locations and conflict zones such as J&K, LWE Areas, North East etc. The aim of CWA is to uplift and support the families of CRPF personnel and mitigate their problems. CWA always support the NOKs and families of CRPF martyrs to address their problems.

Post Pulwama incident lots of donation / contribution have been received from organisations / NGOs / Individuals in CWA hence a separate account has been opened in the name of **CRPF Shaheed Fund CWA**. This will be a separate project under CWA with different aims / objectives.

**1. NAME/TITLE :**

- a) This Fund will be known as **CRPF SHAHEED FUND CWA**.
- b) This Fund is the part of CRPF Family Welfare Association.
- c) PAN Number in the name of CRPF Wives Welfare Association will be used for the operation of this account till further orders.

**2. GENESIS OF FUND :-**

As per decision taken by the Governing Body and CEC members of CWA a Fixed Deposit of Rs. 7,00,00,000/- has been made on 27/03/19 for one year in the State Bank of India, CGO Complex, Lodhi Road under the CRPF Family Welfare Association. A sum of Rs. 48,09,158/- will be generated on maturity of said Fixed Deposit on 27/03/20. While utilizing the fund it is to be ensured that corpus Rs. 7 Crore remains unchanged and interest generated from it shall be used for the welfare of families of CRPF martyrs and deceased as per the aims & objectives of this fund. CRPF officers /personnel who killed in action/operation are treated as martyrs and other than martyrs all CRPF officers /personnel who died during service are treated as deceased for utilizing this fund.

**3. Objectives of the Fund:**

The fund will be used to provide funds/facilities to the families of CRPF martyrs and deceased only. It will be utilized for the following purpose:-

**a) Education:-**

- i. Assistance to the family of CRPF martyrs and deceased for their education including higher, professional and technical education.

**b) Health Care :-**

- i. Assistance to the family on their health-care/ sickness/ hospitalization diseases /ailments

**c) Skill Development:-**

- i. Assistance to the family members of CRPF martyrs and deceased who want to avail any kind of skill training or courses and also for providing equipments/assets for making them self-reliant.

**d) Providing Education Aids:-**

- i. Computer or other educational aids like laptops and tablet etc. can be provided on request or need of family members of martyrs & deceased.

**e) Providing Aid to Differently abled children:-**

- i. Any kind of medical or financial aid can be provided to differently abled family members of martyrs & deceased on request.

**f) Honouring the family members:-**

- i. Honouring deserving family members of martyrs and deceased for their extraordinary work /achievement.

**g) Miscellaneous :-**

- i. Assistance to family of martyrs and deceased on their special request in case of any extreme need.
- ii. Any other case to be decided by Governing Body of CWA as deemed fit.

The Fund will be utilized with the consent of Governing Body and CEC members of CWA.

**4. Benefit will be extended to the family members as mentioned below :**

**i. Details of Family members:**

1. Wife in case of married male member.
2. Husband in case of married female member.
3. Children including step and adopted children.
4. Mother/Father of male/female member.
5. Unmarried dependant brother & Sister.

ii. **Children:**

1. Son including step sons and also adopted sons where the adoption is recognised by the personal Law governing the members and who are wholly dependent on the member.
2. Un-married, widowed and divorced daughter, including step daughter and also adopted daughters where the adoption is recognised by the personal Law governing the members and who are wholly dependent on the member.

**5. Management of the fund:**

- i. The fund will be maintained by CRPF Family Welfare Association at CGO complex Lodhi Road New Delhi. PAN number of CRPF Wives Welfare Association will be used for the operation of this account.

The fund shall be administered by a Governing Body, which shall comprise the following:

**6. MEMBERSHIP:**

- i. President CWA is empowered to co-opt any other member(s) of CWA in the Governing body or as a signatory.
- ii. Membership of the Governing body and signatory of fund shall cease on death, transfer out, insanity or conviction in criminal offence etc.
- iii. Resignation from membership shall be tendered to the President of Governing body and shall not take effect until the President accepts it on behalf of Governing Body.

**7. Source of Income:**

The Fund shall be constituted from and supported by:-

- i. Voluntary donations as and when received.
- ii. Donations or Grants from Central or State Government or other Government and Quasi-Government bodies.
- iii. Donations received from NGOs/Trusts
- iv. Interest generated from the FDs.

**8. Maintenance of Records:-**

- i. The account will be maintained through a separate cash book in the name of scheme i.e. "**CRPF SHAHEED FUND CWA**" which will be signed by the Dy. Comdt(Welfare-II) Dte cum Joint Secretary, DIG(Welfare) Dte cum Secretary and Treasurer of CWA for proper accounting the Fund.
